This contract is between Mountainview Pet Haven and the pet owner whose signature appears below (hereinafter called "Owner").

1. Mountainview Pet Haven hereinafter referred to as the "Kennel", agrees to exercise due and reasonable care to keep its premises sanitary and properly enclosed.

2. Owner agrees to pay the rate for boarding in effect on the date pet is checked into the Kennel, and all future dates booked.

Owner further agrees to pay all costs and charges for special services requested and all veterinary cost for the pet during the time said pet is in the care of the Kennel.

3. The Kennel does not assume and shall not be held responsible for any liability with respect to the animal listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from boarding this animal, or any damages which may accrue from any other cause whatsoever including loss by fire, theft, running away, death, injury to persons, animals, or property, or death or injury to any other animal caused by the within named animal during the term of this contract, whether this animal be on the premises of the Kennel or not. The owner of said animal agrees hereby to be and is solely responsible for any and all acts of behaviour of said animal at any time within the term and time of the contract. The responsibility and or liability of the Kennel in no event shall exceed the sum of Two Hundred Dollars (\$200.00) and the undersigned agrees to limit the responsibility to Two Hundred Dollars for any damages sustained or suffered by reason of the boarding of this animal at said Kennel.

4. The owner of the within named animal specifically represents that they are the sole owner of said animal and that there is not any lien or mortgage against said animal.

5 The Kennel shall have, and is hereby granted, a lien on the animal for any and all unpaid boarding and or other charges resulting from the boarding of said animal with the Kennel. Owner further agrees to relinquish ownership if said animal is not collected and all unpaid charges settled in full within 14 days after the end of the boarding term.

6. If pet becomes ill or the state of the animal's health otherwise requires professional attention, the Kennel, at its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal. Any expenses thereof shall be paid by the Owner. Owner further agrees that all vaccines must be kept up to date and proof maybe obtained by my veterinarian.

7. Any controversy or claim arising out of or relating to this contract shall be settled by arbitration. The arbitrator shall, as part of any decision, determine an award to the prevailing party of the cost of such arbitration and reasonable attorney's fees of the prevailing party.

8. This Contract contains the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, administrators, and assigns of the owner of the within named animal.
